- Full Day schedules include 1-hour break. Half-day schedules include 15-30 minute break. Bring your own food/water.

Important Information: This Registration Agreement is an agreement between you, the team or organization registering above, and Spirit Unlimited, that governs the terms and conditions under which Spirit Unlimited will conduct the camp(s) that you register for. By signing this Agreement you agree to be bound by the terms and conditions of this Agreement, and by the Spirit Unlimited Safety Guidelines, Rules and Regulations and Code of Ethics all of which you acknowledge that you have reviewed and which are available at www.spiritunlimited.com and incorporated into this Agreement by reference. If you cancel any camp(s) that you have registered for, any payment made by you will be retained by Spirit Unlimited as liquidated damages to pay for the costs and expenses that Spirit Unlimited incurs in such cancellation, as the parties agree that it would be impossible or extremely difficult to calculate the actual costs and expenses to Spirit Unlimited resulting from such cancellation. Spirit Unlimited is not liable for any costs incurred by a team or organization (i.e. travel, hotel, bus fees, etc.) due to a camp cancelled due to natural disaster or terrorist activity. This Agreement is governed by Maryland law (except for Maryland's conflict of laws principles) and the parties agree that venue for any legal proceedings will be Howard County, Maryland. In the event of any dispute in connection with this Agreement, you agree to reimburse Spirit Unlimited for its reasonable attorneys' fees. You release and agree to indemnify, defend and hold harmless Spirit Unlimited, its members and employees, from and against all claims, damages and other costs and expenses, including reasonable attorneys' fees, arising out of or related to this Agreement. This Agreement represents the entire agreement between us, is binding on us and our successors, assigns, heirs and personal representatives, and can only be amended in writing.
